

Academic Set-up and Support Facilities

A. Academic Area Groups

The Institute's academic organization consists of faculty from a wide range of disciplines, viz. Economics, Finance, Commerce, Business Management, Computer Science, Agricultural Science, IT, Strategy Monitoring, Psychology, Sociology, etc. Practicing bankers strengthen the faculty by serving the Institute for varying period of time. The present faculty strength is 30. The different functional areas are organized into six Area Groups, namely Finance, Human Resource Management, Information Technology, Money, International Banking and Finance, Rural Finance and Development, and Strategic Planning, Marketing and Control.

B. Activities of the Institute

The activities are conveniently divided into five areas, viz. Research, Consultancy, Executive Training, Education-PGDM (B&FS) and Online Certification Courses. The activities of the NIBM are integrated in nature. Research and consultancy complement each other and the outputs form a very important component of the training and teaching inputs.



○ Research

Research studies initiated by the faculty members form the foundation of various academic activities of the Institute. Most of the research work seeks to address the existing and emerging issues in the banking system. The Institute also conducts Financial and Sponsored Research Projects and Consultancies for various institutions and government agencies including Reserve Bank of India; Government of India; National Bank for Agriculture and Rural Development, leading Public Sector Banks; NBFCs etc.

○ Consultancy

Providing consultancy support to banks and financial institutions is one of the key strengths of the Institute. ○ Executive Training

Banking Operations Management for Payment Banks.

Already, around 22,260 executives from various public sector banks, private sector banks, foreign banks, small finance banks, financial institutions and fintech companies have been awarded the certifications for these courses.

Institute also offers weekend Executive Certification courses with NSE TalentSprint.

○ Publications

○ Library

The library building is with reading room facility and spacious. It has a collection of over 71,000 + books, 15,800+ bound volumes, 80+ journals/magazines. Besides, it receives special reports of committees, task forces and institutions from India and across the world. The library has more than 2,800+ micro-films, video and audio cassettes, CDs, DVDs, VCDs, diskettes/floppies, films and slide-sets on different subjects. The library has around 26000+ e-books and more than 10,000+ e-journals. Library provides various information services to users.

The library subscribes to various databases as follows: Ace Equity, CMIE Economic Outlook (IP) database, CMIE Industry Outlook, CMIE Prowess IQ, EBSCO Business Source Premier Database, EBSCO E- Book Collection, LSEG Workspace (Data terminals), EPWRF database, Financial Times, Harvard Business School Cases, ICC Digital Library – Trade Finance Channel, IMF eLibrary (Free), J-Gate Social & Humanities database, JSTOR, National Digital Library (NDL) (Free), ProQuest ABI/Inform Complete, and Project Syndicate and Scopus. Library also subscribes to plagiarism detection software iThenticate.



○ Computer Services' Center

Another focal point in the Institute is the well-equipped Computer Services Center providing excellent IT Services to the users. The Center is equipped with the state-of-the-art computing facilities to support the research, training and consultancy activities of the Institute. 24x7 Wi-Fi-enabled internet connectivity is also being provided. Our entire campus is wifi enabled.

There is a Fully -equipped Finance lab and a newly-inaugurated NIBM-CCIL Simulation Trading Lab on Campus.

Various analytical software packages like SPSS, EViews, STATA, @Risk, Matlab, NVIVO, etc. are available.



○ PGDM Office

This office facilitates all PGDM activities ranging from publicity, admission, programme execution, examination, placement, convocation, managing student facilities such as hostel, mess, sports, extra-curricular activities and alumni association activities.

○ Medical Services

The in-house dispensary provides basic medical services within the campus. One qualified Resident Medical Officer and a Consultant Doctor are available on call, round the clock. Besides, arrangements with multi-speciality hospitals ensure prompt and full range of medical services.

The course provides a thorough grounding in foundational subjects, imparts advanced training on analytical skills and builds a holistic perspective on the financial services' industry. It also equips the students with a keen appreciation of the business challenges in the financial services' industry and prepares them for coveted managerial roles. As a result, banks and financial institutions have always placed our students in key domains like credit appraisal and management, investment and treasury operations, trade finance, foreign exchange and risk management.



Profile of the Students

Students admitted to the programme are from varied disciplines like engineering, commerce, science and arts. They demonstrate high levels of initiative and energy, capacity for hard work, strong task orientation, willingness to learn, propensity to teamwork, and a passion to excel.



Curriculum

The curriculum covers a broad range of topics related to management of banks and financial institutions. It is designed to progress from foundational inputs on finance, economics, operations, quantitative analysis, organizational behaviour and general management to core concepts in banking systems and products, asset and liability management, credit appraisal and management, risk management, treasury and investment management, international banking and forex management, bank regulation, leadership and strategic management. The students are also equipped with computing skills that are essential for managers in the financial services' industry.

Projects

- ⇒ **Summer Internship [2 Credit]** : After completing three terms in the first year all students have to take up summer internship in an organization for a period of eight weeks. This project gives them an opportunity to participate in banking and financial sector operations/analysis.
- ⇒ **Banking and Finance Project [3 Credit]** : Students undertake a three-month project during Term 4/5 under the guidance of a Faculty Member. It is technical, rigorous, practical and research-oriented. Students are expected to make original contributions or recommendations, based on their analyses, in the final reports. This improves their ability to specialize in advanced topics, of their choice.
- ⇒ **Social Development Project [3 Credit]** : The Social Development Project is a group assignment which allows students to study problems and understand the needs of the society. Students begin this project early in the course and work throughout the entire duration of PGDM. This project instils a sense of social responsibility among the students and develops their ability to work in teams.

Pedagogy

The pedagogy includes classroom lectures, case studies, individual and group assignments, simulation of business operations and field visits. A high teacher-student ratio of 1:9 enhances the scope of personal interactions. The Institute pursues a comprehensive approach to learning in the PGDM programme, based on:

- Interface with practitioners & Executive Development Programmes.
- Institutional and sponsored research studies.
- Faculty insights from research and consultancy.
- Institutional conferences and seminars on emerging issues in banking and finance.
- Rigorous projects on banking and finance.

Evaluation

The evaluation process is continuous and aimed to: (a) Elicit maximum performance from the students; (b) Give feedback to each student so that they know where they stand in the group, both in relative and absolute sense; and (c) Provide a benchmark so that students are motivated to perform better.

The faculty may use different instruments like tests, quizzes (surprise and announced), home assignments, term reports, individual as well as group exercises, classroom participation, problem-solving exercises using computer, etc. Mid-term examination and the end-term examination are integral parts of the continuous evaluation.

The Institute follows a relative grading system to determine the academic performance of each student.



Convocation

Convocation for the award of diploma and presentation of merit awards is held within a month of the announcement of the final results of the programme.



About PGDM Placement

The National Institute of Bank Management (NIBM) continues to set benchmarks in management education with remarkable placement and internship outcomes, underscoring its strong industry connect and the exceptional caliber of its students.

The PGDM Batch of 2023–25 achieved an outstanding 100% placement record, attracting 40+ reputed recruiters across FinTech, Banking, NBFCs, Consulting, and IT sectors. Leading organizations such as Accenture, Barclays, Bank of America, BNY Mellon, KPMG, PwC, Tata Capital, Wells Fargo, Cognizant, Auronova Consulting, and Protiviti offered diverse roles in Risk & Compliance, Corporate Banking, Analytics, Consulting, Product



Management, and Technology. The placement season recorded the highest package of ₹26.59 LPA, median of ₹15 LPA, and an average of ₹20.46 LPA for the top 10% of the batch.

Continuing this success, the PGDM Batch of 2024–26 began securing Pre-Placement Offers (PPOs) and premium slot placements even before the Placement week scheduled in November 2025, with 43 students placed at packages ranging from ₹13 LPA to ₹19 LPA. Students from the 2025–27 batch have also begun securing internship offers early, with stipends like ₹1,50,000 for roles in Risk & Compliance and Risk Consulting from organizations like Barclays, BNY Mellon, and EY.

PGDM Admission Process

Eligibility Criteria

The candidate must hold a Bachelor's Degree, with at least 50% marks (45% marks in case of candidates belonging to reserved category) or equivalent CGPA, awarded by any of the Universities incorporated by an act of the central or state legislature in India or other educational institutions established by an act of parliament or declared to be deemed as a University under Section 3 of the UGC Act, 1956, or possess an equivalent qualification recognized by the Ministry of HRD, Government of India. The percentage of marks obtained by the candidate in the bachelor's degree would be calculated based on the practice followed by the university/institution from where the candidate has obtained the degree. In case the candidates are awarded grades/CGPA instead of marks, the conversion of grades/CGPA to percentage of marks would be based on the procedure certified by the university/institution from where they have obtained the bachelor's degree. In case the university/ institution does not have any scheme for converting CGPA into equivalent marks, the equivalence would be established by dividing the candidate's CGPA by the maximum possible CGPA and multiplying the result with 100.

Candidates appearing for the final year of bachelor's degree/equivalent qualification examination and those who have completed degree requirement and are awaiting results can also apply. Such candidates must produce a certificate from the Principal/Head of the Department/Registrar/ Director of the University /Institution certifying that the candidate is currently in the final year/is awaiting final results and has obtained at least 50% marks or equivalent based on latest available grades/marks. Such candidates, if selected, will be allowed to join the programme provisionally only if they submit a certificate from the Principal/Registrar of their college/institute stating that they have completed all the requirements (the results may, however, be awaited) for obtaining the bachelor's degree/equivalent qualification on the date of

issue of the certificate. Their admission will be confirmed only when they submit the mark sheet and a certificate of having passed the bachelor's degree/equivalent qualification referred to in the certificate issued by Principal/Registrar of their college/institute with at least 50% marks (45% marks in case of candidates belonging to reserved category). The deadline for submission of the mark sheet and the certificate is October 31, 2026. Non-fulfillment of this condition will automatically result in the cancellation of the provisional admission. NIBM would not allow any candidate to join the programme in case the candidate is unable to complete all the requirements for a bachelor degree on or before June 30, 2026. Instances of any incorrect information and process violation detected at any stage of the selection process will lead to disqualification of the candidate from the selection process. If such instances go undetected during the current selection process but are detected in subsequent years, such disqualification will take place with retrospective effect.

Screening Test

Applicants are required to appear for the Common Admission Test (CAT) conducted by IIMs in 2025 or GMAT. While applying for CAT the applicants may indicate their intention of applying to NIBM (non-IIM institutions).

Scores secured by the candidates in Common Admission Test (CAT) conducted by IIMs, Graduate Management Aptitude Test (GMAT) will be used for the purpose of screening. CAT will be the benchmark for screening of applicants. IIMs or any other Institutions will have no role either in selection process or in the conduct of the programme.



As the number of applications from each socio-economic category will be different threshold CAT scores for each category may be determined. However, in order to ensure desired competence of the candidates so that the candidates admitted in PGDM (B&FS) will be able to cope with the course a minimum score for each category has been set as below:

Note: The indicative threshold has been given for comparison purpose only. Cut -off score for CAT and GMAT are decided every year after receiving all the applications.

Selection Process

The selection of candidates for admission will be based on Scores arrived at in the Screening Process, Personal Interview, Oral Communication Test, Academic Performance, Participation in extracurricular activities and Work experience.

Oral Communication Test and Personal Interview (OCT & PI): OCT may be conducted by the panel for personal interviews by giving a topic to the candidates and asking the candidate to speak on the topic. The panel will also score the candidates against extracurricular activities and work experience.

Admission interviews are expected to take place during April/May 2026 at the selected centers provided by NIBM which are Bengaluru, Delhi, Kolkata, Lucknow, Mumbai & Pune.

Academic Performance: Average of marks secured by the candidates in SSC and HSC will be considered for assessing the academic performance of the candidates.

Note: The Oral communication Test and Personal interview (OCT&PI) will be conducted offline for shortlisted candidates only. Candidates need to select the preferred city for OCT& PI round while applying for the NIBM Admission. The options are limited to a few cities chosen by NIBM.

Last date to submit Online Application is March 20, 2026

Admission Offer

Successful candidates will be intimated of their final selection during May/June 2026. The selected candidates must pay the first instalment of fees within two weeks from the date of offer of admission, failing which they would forfeit their seat to the person next on the waiting list.
